

In addition to the provisions contained in the *Eurimage Standard Terms and Conditions of License*, the following *Eurimage End Users Terms and Conditions of License* shall apply to the License of QuickBird Satellite Data/Products. Provisions herein contained will prevail on the relevant provisions of the *Eurimage Standard Terms and Conditions of License*.

1. Licenses Granted.

Subject to the terms and conditions of this End User Terms and Conditions of License ("License Agreement" or "License"), Eurimage grants to the purchaser of this License ("End User") a limited, non-transferable, non-exclusive, "Single Organization" License to use the QuickBird imagery data, or related software or documentation ("Products") for which this License is purchased, and to develop Derived Works, as defined below. This License Agreement shall govern the rights and obligations of the Parties, it shall be accepted by each individual End User upon the signature of the Order Form for the Products and will be effective at the time of delivery.

2. Definitions.

For the purposes of this License Agreement, the following terms shall have the noted meanings.

"Single Organization" means the Organization which is the owner of the License. It includes multiple Users solely within one corporation or government agency at multiple locations within a single country: e.g. one corporation (but not subsidiaries), one national, regional or city governments (all departments). The 25 countries of the European Union are treated as a single country.

"Derived Works" are works containing imagery from the Products and are covered by this License. Derived works that do not contain imagery data from the Products are not covered by this License. For example vector maps (features, buildings, waterlines, classification) derived from a Product are outside of this License.

3. License Granted and Permitted Uses.

By accepting the terms of this license, the End User is permitted the rights to use the Products internally at its facilities within its country of residence and to:

- (a) Make an unlimited number of copies for the internal use of the End User.
- (b) Modify the Products or use the Products to create derived works.
- (c) Provide the Products to contractors for the development of a derived work for the internal use of the End User only.
- (d) Release hardcopy prints on a limited non-commercial basis, contained in research reports or similar publication, provided that the End User conspicuously marks the copyright.
- (e) After notifying Eurimage of the URL that will be used, post Products and derived works to Internet web sites, provided that downloading of image data and screen capture is precluded.
- (f) After notifying Eurimage of the URL that will be used, post derived works to Internet web sites and allow downloading provided that the quality is not better than 8 bit, the image is not georeferenced, the amount downloaded is not more than the amount which can be displayed on a screen at one time, and the image is downloaded at the same resolution as displayed on the screen. Proper copyright must be conspicuously marked.

4. Prohibited Uses.

All rights not expressly granted to the End User are retained by DigitalGlobe and its licensor. These include, but are not limited to the following:

- (a) Copy or reproduce (even if merged with other materials), other than as consistent with the Permitted Uses.
- (b) Sell, license, transfer, disclose, the Products or use them in any manner not expressly authorized by this Agreement.
- (c) Alter or remove any copyright notice or proprietary legend contained in or on the Products. End User agrees that any embodiment of the Products permitted under this Agreement will contain the following notice: "Includes QuickBird Products © DigitalGlobe™, distributed by Eurimage".

5. Limitations and Disclaimer of Warranty.

Products are delivered with a limited warranty. Eurimage warrants that the data delivered will materially conform to the applicable written specifications for the Products and to the area of interest ordered. This foregoing warranty covers only problems reported to Eurimage within fifteen (15) days of delivery of such Products to End User. Products, which do not comply with the

warranty during the aforementioned warranty period and are returned to Eurimage within twentytwo (22) days of delivery of such Products to the End User, will be repaired or replaced at Eurimage option. If Eurimage cannot, or determines that is not practical to, repair or replace the returned Product, the price therefore paid by the End User will be refunded. With the exception of the preceding warranty, the products are provided without warranty of any kind, and all warranties of merchantability and fitness for a particular purpose are disclaimed. Eurimage does not warrant that the products will meet the end user's needs or expectations, or that operations of the products will be error free or uninterrupted. No information provided by Eurimage or its agents, employees, resellers or distributors, shall create a warranty, or in any way increase the scope of this limited warranty, and the end user is not entitled to rely on any such information.

6. No Consequential Damages.

In no event shall Eurimage be liable, within the limit set out by the law, for any claim of loss incurred by the End User, including without limitation, compensatory, incidental, indirect, special, consequential, exemplary or other noncompensatory damages, such as lost profits, loss of goodwill, opportunity costs, cost of cover, or cost of replacement goods, irrespective of whether Eurimage knew or should have known of the likelihood of such damages. The End User acknowledges that no representations made by third party distributors or resellers are binding upon Eurimage. This limitation applies to all causes of action including but not limited to breach of contract or warranty, negligence, strict liability, misrepresentation and other torts. If Eurimage's limitation of liability set forth in this agreement is for any reason held unenforceable or inapplicable, despite the limitations contained herein, the End User agrees that Eurimage's liability shall not exceed fifty percent (50%) of the license fees paid by the end user to Eurimage with respect to the products at issue over the six (6) month period preceding the claim.

7. Governing Law.

This License Agreement shall be construed and enforced in accordance with the laws of Italy. The parties hereto agree that the Italian Courts shall have exclusive jurisdiction for any dispute or controversy concerning, arising out or connected with this License Agreement and that, within such jurisdiction, the Courts of Rome shall be competent. The parties mutually acknowledge that, for the purposes and effects of Article 17 of the Brussels Convention of 27th September 1968, as amended, the jurisdiction of the Italian Courts has been agreed only in favor of Eurimage.

8. Miscellaneous.

- (a) The End User acknowledges, and will cause its employees and agents to acknowledge, that DigitalGlobe and its licensors will own all rights in any copy, translation, modification, adaptation or other Derived work that End User or its contractors may create that is covered by this License.
- (b) This License Agreement, together with the *Eurimage Standard Terms and Conditions of License*, constitutes the complete and exclusive agreement between Eurimage and the End User relating to its subject matter. This License Agreement supersedes all prior and contemporaneous representations, correspondence, proposals or agreements relating to its subject matter, whether oral or written. This License Agreement may be modified only by a written amendment signed by both Eurimage and the End User. If any provision is determined to be invalid or unenforceable, the remaining provisions of this License Agreement shall continue to be valid and enforceable. Neither this License Agreement nor any of the rights granted by it may be assigned or transferred by the End User without the prior written consent of Eurimage. This restriction on assignments or transfers shall apply to assignments or transfers by operation of law, as well as by contract, merger or consolidation. Any attempted assignment or transfer in derogation of this prohibition is void.
- (c) The End User shall be responsible for obtaining any and all required governmental authorizations, including but not limited to any export or import licenses, and foreign exchange permits.
- (d) The End User shall be responsible for payment of all taxes, fees, assessments or levies on the Products, or arising out of or imposed by reason of this License Agreement, except for any tax based on Eurimage's annual net income.
